Intro

- Hello, may I speak to (Patient's First name and Surname)? My name is (XXX) and I'm calling from Oxford University following your positive COVID-19 test result. We run a study looking for COVID-19 treatments to help people feel better more quickly.
- **Are you interested in hearing more details about how you could help us to develop new treatments and take part?** [If yes continue, if no end call politely.]
- We are contacting people like you who have tested positive for COVID-19 and your information has been provided to us by NHS Digital.
- If you chose to take part you would be randomly assigned to receive either one of the treatments we are looking at or usual care [**briefly explain the current possible arms**]. We would send a participant pack to your home and all follow-up contact would be online or over the phone.
- **Does that sound like something you would be interested in?** [if yes continue if no ask if they can tell you why to help design future studies and end call politely]
- **Are you currently feeling unwell and if so, may I ask what symptoms you have?**
[If yes and have any likely related symptoms, move to next question]

[If no] I'm glad you're feeling well, this study is only for people who feel unwell so would not be suitable for you, thank you so much for your time today.

- **Can I ask how long you have been feeling unwell for?**

[If over 14 days] – As we are aiming to treat the illness early on, we are looking for people who have been unwell for less than 14 days, so this study is not suitable for you. Thank you so much for your time though and I hope you feel better soon.

[If less than 14 days] – **Could I please check your age?**

[If 18 or over] **It looks like you may be eligible for the study, would you like to go through the forms over the phone now – which will take around 25-30 minutes?**

If they say yes, please click on the screening link <https://secure.phc.ox.ac.uk/nhsd> and go through the forms with them

[If under 18] Unfortunately you are not eligible to take part in the trial, thank you for your time and we hope you feel better soon

- If they are potentially eligible but do not have time to go through the forms:

Do you have an email address?

[If Yes] - Great, I can send you a copy of our information leaflet and link to register directly on our website?

[if yes, see below instructions for Sending Link via Email]

Thank them for their time and end the call.

If appropriate:

You have the right to opt out of any future communications from PRINCIPLE should you wish to do so. PRINCIPLE will not retain your data should you choose not to take part.

Dear ***,

Thank you very much for your time today and interest in the PRINCIPLE trial.

* These symptoms may include, but are not limited to: a high temperature; a new, continuous cough; loss or change to your sense of smell or taste; sore throat; shortness of breath; general feeling of being unwell; muscle pain; diarrhoea and vomiting.
